

Mission: A Challenge Case Report is an opportunity to help educate neurologists in training and others with a unique case presentation. Below are guidelines along with a sample manuscript template to reference when preparing your manuscript. Thank you for your contribution to the literature.

Authors

- ✓ List names, degrees, academic position, department, institution, city, state, mailing address for every author along with a telephone number (no more than 6 authors per article, please).
- ✓ Provide a “headshot” photograph for each author. Each photograph should be saved as a separate file (as .jpg or .tif: ~3 x 4 inches, resolution ≥ 200 dpi).
- ✓ Include financial disclosures for every author.
- ✓ Attest to having obtained patient consent for the case report.
- ✓ Read and agree to the author statement included on page 2 of this document.

Text

- ✓ Your article should be ~**1800 - 2000** words in length (not including references).
- ✓ Please cite all figures, tables, boxes, and videos in text.
- ✓ Kindly include citations for all references in numeric order (1, 2, 3, etc), with a maximum of 15 references.
- ✓ Provide a title for each table, a legend for each figure, and make note of any elements borrowed from other sources (all borrowed elements should have the appropriate permissions for use in place).
- ✓ Please follow the outline on page 3 of this document.

References

- ✓ Your article should include no more than 15 of the most recent, relevant references.
- ✓ Please organize your references into a reference list with references numbered sequentially. The reference list should be included in your manuscript after the summary or conclusion of your article.
- ✓ Follow AMA style for your references. Refer to a recent issue of [Practical Neurology](#) for examples.

Figures

- ✓ Cite each figure in text, number each figure sequentially, and include a brief legend for each figure. The list of figure legends should be included at the end of your manuscript following the reference list.
- ✓ Each image or illustration should be submitted as a separate file. Preferred file formats include .jpg, .tif, or .eps files saved at a high resolution (≥ 300 dpi).

- ✓ Unless you took or ordered the photograph or drew the drawing yourself, each figure must be accompanied by a grant of permission, which can usually be obtained from <https://marketplace.copyright.com/rs-ui-web/mp>.

Tables

- ✓ Cite each table in text, number each table sequentially, and include a table title for each table.
- ✓ Provide each text-based table in the manuscript, 1 per page, after the references.
- ✓ Each table should contain ≤6 columns or 20 rows and include ≤350 characters/cell.

Permissions

- ✓ Submit any documentation granting permission to reprint elements borrowed from other sources along with your article submission. One resource for permissions is the [Copyright Clearance Center](#).

Video, Slideshow, Audio, Digital

- ✓ Contributors are encouraged to submit supplemental digital materials along with their article. These supplemental materials will appear online at www.practicalneurology.com.
- ✓ Kindly cite any digital supplemental materials in the text of your article (see Video 1, available at www.practicalneurology.com).
- ✓ Preferred file formats for video content include .mp4, .mov, and .wmv.

Case Presentation (200–400 words)

Describe patient (use made up initials); do not include gender, biologic sex, or race or ethnicity unless necessary for case. Give symptoms and signs and any acute treatment given.

Diagnostic Process (100–300 words)

Describe all diagnostic studies. If laboratory studies are relevant, present them in a table. Consider supplying an optional video, with audio, up to 3 minutes, of the patient exhibiting symptoms (voiceover or examination).

A figure or table is required in this section, showing or describing clinical or diagnostic findings (eg, facial droop photograph, EEG, MRI or CT, laboratory results); if a video is included, use still frame from video.

Questions and Answers (up to 300 words)

Please provide 2–4 questions about the case, each with 4 or more possible answers, only 1 of which is correct. Label questions numerically and answers alphabetically. Note the correct answer by placing brackets around the letter of the correct answer (eg, [C]).

Case Resolution (150–300 words)

Explain the correct diagnosis, how it was determined, what treatment or management followed, and any follow-up.

Discussion (400–600 words)

Discuss the case in the context of published literature; make sure to address why the correct answers to the questions were correct and why the incorrect answers were incorrect. When possible, include a paragraph from the patient in which they describe their perspective.

If you included a first video and it makes sense to show posttreatment findings, you may include another, with voiceover, no more than 3 minutes long.

If a posttreatment image or table makes sense, please include it. Figures need a descriptive legend of ~25 words.
